Dear Parents/Guardians:

Thank you for considering HVRP Academy for your student's education! We have adopted an admissions policy that opens the school to families who are like-minded spiritually, who are supportive of our doctrine, objectives, and standards of education, and whose children meet our enrollment standards. Our purpose is to serve families from our church, who desire much more than private education, namely a strong Christian conservative education for their children.

Before applying for admission to our school, please read our Student Handbook, that will introduce you to many of our school's policies, procedures, beliefs, and expectations for both parents and students.

The first several pages of the Handbook explain our Christian Pentecostal purpose, mission, and beliefs. This school unashamedly believes, teaches, and practices the instructions within the Bible, which is the infallible Word of God. Since you are a member of our Church, we assume that you agree with our religious mission and beliefs. However, if you do not adhere to our mission and beliefs, enrolling your child in our school will likely cause him or her confusion. For example, if a question regarding Biblical lifestyles arises in Chapel or your child's classroom, the teacher or pastor will answer from a Biblical viewpoint consistent with our mission and belief statement. If your beliefs and lifestyle choices are not in agreement with our doctrinal stance, that answer will likely create conflict in your child's heart and mind. We respect your desire to place your child in the best possible learning environment, but we also ask the parents before they become church members and before they enroll their child in our school, to adjust their views and be in full agreement with our doctrinal positions, as this will ensure a healthy spiritual and academic development for your child.

Biblical principles are integrated into every subject taught at our school. Our faculty and staff are committed not only to academic excellence, but also to teaching students how to apply the truths of God's Word to every aspect of life. If you agree with the teachings of God's Word and our doctrine, this school will complement the beliefs and ideals your child is taught at home. We look forward to partnering with you to educate your child in God's Truth.

Student Admissions Evaluation Criteria

Prospective students for HVRP Academy will be evaluated and considered for admission based on the following criteria:

Membership Considerations

HVRP Academy is a covenant school, which means that the parents/guardians of prospective students must be members in good standing of Happy Valley Romanian Pentecostal Church.

Spiritual Considerations

- 1. Personal Christian commitment of parents and student.
- 2. Willingness of parents and student to be supportive of the school's Christian philosophy of education
- 3. Willingness of parents and student to support the administration and faculty in carrying out the goals and programs of the school.

Age Consideration: Children entering Kindergarten must be 5 years old before September 15th.

Behavioral Consideration

- 1. History of acceptable behavior and citizenship in previous school and community/social experiences.
- 2. Agreement of parents and student to abide by the Christian code of conduct and behavior standards established by the school.

Academic Consideration

- 1. Documented record of acceptable grades and attendance in previous school experience.
- 2. Acceptable scores on achievement tests.

Personal Consideration

- 1. Student's special interests, talents, and skills.
- 2. HVRP Academy makes no distinction in its admission policy on the basis of race, color, or national and ethnic origin.

Admissions Process:

Step I.

Provide all the documents listed in step I. of **Admissions Checklist**, as follows:

- 1. Prospective families, please carefully read the Application for Enrollment. Complete and **return pages 5 to 12 of the Application for Enrollment**.
- 2. Please take the **Student Recommendation Form** (attached) to the Sunday school teacher or director to fill it out and **return it straight to the school, in person or via email**: HVRPAcademy@gmail.com.
- 3. Please complete and return the Student Record Request Form (attached).
- 4. Provide a copy of the birth certificate.
- 5. Please carefully read the Student Handbook (accessible online). Sign and return last page of handbook (Handbook Receipt and Agreement Form).

Completed application forms and school records will be reviewed by the school administration.

 Applicants will be notified if they are accepted for the next step, not accepted, or on the waiting list.

Step II.

- If necessary, you will be notified to schedule your student to complete incoming academic assessment exams.
- If we do not have enough seats for everyone that applies, students with lower grades from previous school, and/or lower results on the academic assessment exam, will be added to the waiting list and will be notified as openings become available for possible enrollment.
- Applicants will be notified if they are accepted for the next step, not accepted, or on the waiting list.

If accepted, applicants must respond by completing and returning the documents listed in step III. of Admissions Checklist, and paying the Registration Fee within two weeks of notification, to be added to the enrollment list.

If accepted:

- 1. Complete, Sign, and Return all the Documents listed in step II. of Admissions Checklist.
- 2. Pay the Registration Fee within two weeks of notification.
- Review tuition and financial payment options and complete a Financial Agreement.

Step III.

- 1. Students who successfully pass all portions of our admissions process will receive an acceptance letter and be welcomed to our HVRP Academy student team!
- 2. Schedule a getting-to-know-you family meeting with our Principal, you, and your student(s).

Happy Valley Romanian Pentecostal Academy's Mission Statement

Happy Valley Romanian Christian Academy's mission is to partner with parents so that students may know Jesus Christ, grow and mature through a Christ-centered education, and be equipped to positively impact the world for God's glory.

Below is a summary of HVRP Academy's Statement of Faith and Position on Critical Issues. Please refer to our Student Handbook for additional details.

Our Statement of Faith and What We Believe

- a. The verbal inspiration of the Bible;
- b. One God eternally existing in three persons: the Father, the Son and the Holy Ghost;

- c. Jesus Christ is the only begotten son of the Father, Conceived of the Holy Ghost, and born of the Virgin Mary.
- d. Jesus Christ was crucified, buried, and raised from the dead. He ascended to heaven and is today at the right hand of the Father as the Intercessor;
- e. That all have sinned and come short of the glory of God, and that repentance is commanded of God for all and is necessary for forgiveness of sins;
- f. That justification, regeneration, and the new birth are wrought by faith in the blood of Jesus Christ;
- g. In sanctification subsequent to the new birth, through faith in the blood of Christ;
- h. Holiness to be God's standard for living people;
- i. In the baptism with the Holy Ghost subsequent to a clean heart;
- j. In speaking with other tongues as the Spirit gives utterance, and that it is the initial evidence of the baptism of the Holy Ghost;
- k. In water baptism by immersion, and all who repent should be baptized in the Name of the Father, and of the Son, and of the Holy Ghost;
- 1. Divine Healing is provided for all in the Atonement;
- m. In the Lord's Supper and washing of the saints' feet;
- n. In the premillennial second coming of Jesus: First, to resurrect the righteous dead and to catch away the living saints to Him in the air. Second, to reign on the earth a thousand years.
- o. In the bodily resurrection, eternal life for the righteous and eternal punishment for the wicked.

Statement Of Final Authority On Matters Of Faith And Conduct

This statement of faith does not exhaust the extent of our beliefs. The Bible itself, as the inspired and infallible Word of God that speaks with final authority concerning truth, morality, and the proper conduct of mankind, is the sole and final source of all that we believe. For purposes of HVRP Academy's faith, doctrine, practice, policy, and discipline, the senior Pastor of the Church is the school's final interpretive authority on the Bible's meaning and application.

Our Position on Critical Issues

The joy of sharing the person of Christ and living in unity as a body of believers is, in part, the realization that we have differences in areas nonessential to salvation and that through this recognition and acceptance we can mutually experience that which brings about patience, understanding and love among believers (Rom. 15:5). It is equally important to clearly articulate our position on certain critical issues that are foundational to the mission and values of the school.

Foundational

The Board of HVRP Academy takes a clear position in opposition to each of the following: (1) drunkenness (Eph. 5:18); (2) abortion (Lev. 18:21); (3) premarital sex/extramarital sex (I Thes. 4:3); (4) homosexuality (Rom. 1:26, 27; Lev. 18:22); (5) pornography (Ps. 101:3a); (6) Marriage outside of one biological man and one biological woman (Gen. 2:18-25).

Qualified

The Board of HVRP Academy takes a qualified position on the following issues: (1) legal vices; (2) euthanasia; (3) divorce; (4) creation; (5) gender.

Legal Vices:

As children of God filled with the Holy Spirit, we believe that gambling or the use of tobacco and alcoholic beverages are sinful behaviors, and vices through which the devil enslaves people.

Euthanasia:

There is a wide variance of definition of the term euthanasia. The definition, which the Academy would take a stand against, would be the willful act of inducing or speeding up the death process.

Divorce:

God's design for His children would have a biological born man and a biological born woman married only to each other for a lifetime. Inasmuch as there are different interpretations of the Biblical reasons for divorce and God's view of the same, the issue would be referred back to the individual, the home, or the church for a final decision.

Creation:

We teach that man was created by God and in His image (Gen. 1:27) and believe there is compelling evidence for Creation and the Flood (Gen. 6-8); all things in the universe were created and made by God in the six literal days of the creation week described in Genesis 1:1-2:3, and confirmed in Exodus 20:11. We believe that none of the Biblical account of Creation and the Flood needs compromising. What we teach in this regard is consistent with the Bible record.

Gender:

We embrace the Biblical teaching regarding gender identity and believe the biological gender we are born with was God's intention (Gen. 1:27; Psalm 1:39).

Statement on Marriage, Gender, and Sexuality

We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God (Genesis 1:26-27). Rejection of one's biological sex is a rejection of God's sovereign plan for one's life. At HVRP Academy, any efforts to deny one's biological sex through, for example, modes of dress, chemical intervention, or surgical procedures are impermissible.

We believe that the term "marriage" has only one appropriate meaning: the uniting of one biological born man and one biological born woman in a single, exclusive union, as delineated in Scripture (Genesis 2:18-25). We believe God's design for marriage is the union of one man and one woman (Genesis 2:18-25).

Marriage between one biological man and one biological woman uniquely reflects Christ's relationship with His church (Ephesians 5:21-33). We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other (1 Corinthians 6:18; 7:2-5; Hebrews 13:4). We believe that God has commanded that no intimate sexual activity of any kind be engaged in outside of marriage.

We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography) is sinful and offensive to God (Matthew 15:18-20; 1 Corinthians 6:9-10).

We believe that in order to preserve the function and integrity of HVRP Academy as part of the Body of Christ, and to provide a Biblical role model to the HVRP Academy members and the

community, it is imperative that all persons employed by HVRP Academy in any capacity, or who serve as volunteers, agree to and abide by this Statement on Marriage, Gender, and Sexuality (Matthew 5:16; Philippians 2:14-16; 1 Thessalonians 5:22).

We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21; Romans 10:9-10; 1 Corinthians 6:9-11).

We believe that every person must be afforded compassion, love, kindness, respect, and dignity. (Mark 12:28-31; Luke 6:31). Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of HVRP Academy.

NON-DISCRIMINATION POLICY

Based on our belief that the Bible teaches that:

- All people are created equal in the image of God; (Genesis 1:27)
- All have sinned and come short of the glory of God; (Romans 3:10, 12, and 13)
- All are loved by God; (Romans 5:8, John 3:16)
- All need salvation in Christ; (Acts 4:10-12)
- And that God is no respecter of persons (Romans 2:11, Ephesians 6:9)

HVRP Academy provides equal opportunity in regard to enrollment, employment, and access to all activities or programs for all who are members in good standing of Happy Valley Romanian Pentecostal Church accept and uphold the Statement of Faith and Constitution of the Happy Valley Romanian Pentecostal Church regardless of gender, race, color, or national origin and complies with the Americans with Disabilities Act.

Parent/Guardians' Commitment and Acknowledgment

By signing below, I fully acknowledge and understand that my child will be taught spiritual truths in accordance with Scripture. I also commit to support the expectations for proper student behavior as defined by the Student Handbook, reinforce academic coursework and homework completion, and regular class attendance and participation.

- 1. We understand the Bible teaches us that, as parents, we are responsible for the education of our children, and it is our desire that HVRP Academy assist us in this responsibility.
- 2. We commit to support and partner with HVRP Academy in teaching and reinforcing Christ-centered character traits and behaviors such as integrity and respect for teachers, faculty, leaders, instructors, parents, and other students, as well as self. To develop Godly character, leadership skills, excellence in academics and life, and patriotism defined as support and respect for our country.
- 3. We invest authority in the school to discipline our child when necessary. We further agree that we will cooperate and discipline our child in the home as needed (Proverbs 13:24). We will also read the school discipline policy that is in the student handbook.
- 4. We pledge our fullest cooperation to keep doctrinal controversy and denominationalism out of the school at all times.
- 5. We understand that the parents are the natural leaders of their families. Children will follow if parents give strong Christ-honoring leadership. We are committed to work hand in hand with HVRP Academy in order "to train up our child in the way he should go" (Proverbs 22:6).
- 6. We understand that the school exists to support the values of the Christian home. Our home is committed to upholding strong biblical standards of lifestyle, including commitment to and involvement with our church.
- 7. We understand that our failure to report psychiatric counseling, any prescribed program of medication, or involvement with juvenile authorities during the past three years may be cause for immediate dismissal.
- 8. We agree to support the school with our prayers and with a positive attitude. Complaints or negative comments will be shared only with the teacher, administrator, or person involved, and not with our child or other people, following the Matthew 18 principle.
- 9. We understand that the school reserves the right to dismiss any student who does not:

- a. Respect and observe spiritual and/or behavioral standards.
- b. Cooperate with our educational goals.
- c. Conform to the dress and hair code policy.
- 10. We understand that if at any time the school determines, in its sole discretion that our actions do not support the ministry, or reflect a lack of cooperation and commitment to the home and school working together, the school has the right to request withdrawal of the student.
- 11. We understand the school retains the right to refuse admission to or to remove from enrollment any student whose custodial parent is in cohabitation or a same-sex relationship.
- 12. We give permission for our child to go on field trips arranged by the teacher and approved by the administration. The educational trips will be properly supervised, and our family insurance program will cover our child. We will not hold the school, administration, or faculty responsible in case of accident. Notification will be given us prior to each field trip.
- 13. We understand that in the event our child damages school property, assessments will be made to cover these damages, including breakage of windows and abuse of other personal property.
- 14. We understand that the school will work with the State of Arizona and the parents to obtain and work within the budget covered by the state voucher program, called Empowerment Scholarship account (ESA) program.
- 15. We understand that tuition not covered by the State and/or other grants (if any) will be the responsibility of the parents, and will be divided into eleven monthly payments. The first payment is due August 1, and on the first day of each of the following ten months. The last payment is due on June 1. Any payment received after the seventh day of the month will be considered late, and our account will be assessed a \$25 late charge. When an account becomes more than 60 days past due, the student will not be allowed to attend class until the account is brought current.
- 16. We understand that graduating seniors must make their final tuition payment before participating in graduation ceremonies.

I understand that submitting this application does not guarantee my child's admission to HVRI
Academy, and that the non-refundable application fee is due with my application submission.
